The following fees were approved by the Board of Selectmen on August 9, 2010 to be effective on September 1, 2010.

Existing Commercial Structure:	\$110.00 plus \$33.00 per each 100 Amps (or part thereof) of service increase
Service Change:	\$33.00 per each 100 Amps (or part thereof) of service increase

1. Work started without a permit – Fee to be doubled.
2. Reinspection of work - \$30.00 paid in advance.
3. Administrative Fee - \$50.00
Fee charged for any amendment to a permit that is already issued or to renew an expired permit.
4. Estimated construction costs shall be calculated by the Director of Inspectional Services or Designee.
5. If plan review by outside consultant is deemed necessary by the Director of Inspectional Services, the cost shall be paid by the applicant.
