1. Work started without a permit – Fee to be doubled.
2. Reinspection of work - \$30.00 paid in advance.
3. Administrative Fee - \$50.00
Fee charged for any amendment to a permit that is already issued or to renew an expired permit.
4. Estimated construction costs shall be calculated by the Building Inspector.
5. If plan review by outside consultant is deemed necessary by the Building Inspector, the cost shall be paid by the applicant.
