#### **Girl Scout House**

Committee members discussed the need for a comprehensive assessment of the historic building. Committee members agreed this approach would be best for longterm preservation. Once the full scope of improvements is known, the project could possibly be completed in phases.

Tony Kelso made a motion, seconded by Kathy Cross, to continue the discussion on the Girl Scout House until a consultant can perform an assessment of the building. Motion passed unanimously 5-0.

#### **Pilgrim Church Clock**

Tag Carpenter informed the Committee that he is awaiting a revised estimate from the applicant.

Tag Carpenter made a motion, seconded by Kathy Cross, to continue the discussion on the Pilgrim Church clock repair until a revised estimate is received. Motion passed unanimously 5 - 0.

#### DAHT - Harrington

Committee members discussed the 250K reimbursement of Duxbury Affordable Housing Trust for 761 Temple Street.

Tag Carpenter made a motion, seconded by Tony Kelso, to transfer funds from the undesignated fund balance to Duxbury Affordable Housing Trust. Motion passed unanimously 5-0.

#### **DAHT - East Street**

Committee members noted there is no appraisal and plan survey is incorrect. Discussion was tabled until next meeting.

#### CPC - Open Space & Recreation Plan

Committee members discussed the Open Space and Recreation (OS&R) plan which is required by the state to be updated every seven years. A meeting with Old Colony Planning Council (OCPC) is scheduled at the end of November. The meeting will determine which portions of the plan OCPC can assist with. Since budget is not known, discussion was tabled until after meeting with OCPC.
