## **CONSERVATION FUND EXPENDITURES**

Joe Grady explained the Commission has previously approved money for appraisals by LandVest for two properties; farmland on Temple Street owned by Harrington and for a parcel of land on Summer Street owned by DeLorenzo. Some additional funding for GIS maps and hypothetical plans to be done as part of the Phase II work is needed for both appraisals.

Robb D'Ambruoso made the following motion: to approve the expenditure of \$550 from the Conservation Fund for appraisals of a parcel of land on Summer Street by LandVest. This is in addition to the \$4,000 previously voted on December 6, 2016. The motion was seconded by Sam Butcher.
