Minutes of October 19, 2021

The Duxbury Conservation Commission met on Tuesday, October 19, 2021 at 7:00 p.m. via remote Zoom videoconferencing.

Members Present: Robb D'Ambruoso, Chair; Scott Zoltowski, Vice-Chair; Sam Butcher, Tom Gill, Mickey McGonagle, Holly Morris and Corey Wisneski.

Meeting was called to order by Chair, Robb D'Ambruoso at 7:03 p.m.

Mr. D'Ambruoso read the following preamble: Pursuant to Governor Baker's Chapter 20 of the Acts of 2021 dated June 16, 2021, An Act Relative to Extending Certain Covid-19 Measures Adopted During the State of Emergency regarding suspending certain provisions of the Open Meeting Law, G.L. c. 30A, §18, the Town of Duxbury's Board and/or Committee meetings will be conducted via remote participation to the greatest extent possible with members.

PUBLIC HEARING; CHARLES HUSK; 160 MARSHALL STREET; DECK (after the fact) SE18-1978

Robb D'Ambruoso read the SE18-1978 Legal Notice and asked if a representative for the applicant was present. No representative was present. Joe Grady summarized the Commission's two recent site visits to the project noting the deck, constructed on sono tubes, is located on the Coastal Bank, appears to be in the Velocity Zone, and is not 35 ft. from a tidal flat. The project, therefore, does not meet the Duxbury Wetland Bylaw Rules and Regulations. Discussion followed on the Commission's authority and the long violation history of this applicant.

Sam Butcher made a motion, seconded by Tom Gill, to deny the SE18-1978 Notice of Intent and require the deck's removal from its current location to an area outside any Wetland Resource Area Buffer Zone within 21 days. Motion passed unanimously on a roll call vote: Sam Butcher, yes; Tom Gill, yes; Mickey McGonagle, yes; Holly Morris, yes; Corey Wisneski, yes; Scott Zoltowski, yes; and Robb D'Ambruoso, yes.

Motion carried 7 - 0.

PUBLIC HEARING; COREY/DUXBURY CONSTRUCTION; 32 LINDEN LANE; PIER WITH STAIRS, GANGWAY AND FLOAT

SE18-1979. Robb D'Ambruoso read the SE18-1979 Legal Notice. Because of a publishing error, the Legal Notice for this project must be readvertised and the Public Hearing continued to November 2. 2021 at 7:15 p.m.

 inspected the property and he has an As-Built Plan. He recommended the
 Commission issue a Certificate of Compliance.

There are five Special Town Meeting articles:

- Article 1 is the purchased of 64.7 acres of Pink Family land off Old Cordwood Path. The property contains 27.57 acres of working cranberry bogs. The property "Open House" last Sunday, October 17, 2021 was well attended. The Pink Family was harvesting cranberries during the "Open House". Another "Open House" is scheduled for Saturday, October 24, 2021 at 1p.m. It is important to get everyone out to vote "yes" on Article 1.
- Articles, 2,3, and 4 are town business articles.
- Article 5 is a Citizens Petition to halt tree clearing on the town-owned
 Delorenzo property. The property is being prepared for farming. A "No" vote
 is required to continue the land preparation. The Selectboard and Finance
 Committee have both voted not to support the petition. Joe Grady reviewed
 the presentations and discussion at last night's (October 18, 2021)
 Selectboard meeting.
