- Selectboard should elevate this work
- Potential Next Steps: survey community
- o SS: Two lines of advancement; 1) behavioral and attitudinal, 2) operational
 - Operational: Jeannie provided variety of resources from Massachusetts Municipal Association (MMA); clear that municipalities in the commonwealth are moving forward on DEI related issues in their municipalities; MMA has methods to move forward, check progress if Duxbury follows similar tracks, then our municipal gov't is taking action
 - Behavioral: Open dialogue through various town organizations; significant advancement in various non-governmental institutions; clear commitment from a various organizations in town
 - As a result, community is advancing on these two fronts; this is an iterative process
 - Can we ask consultants why there were no commitments to the RFQ? Use that information to decide on committee's next steps
- KW: Would like to commit to a survey and / or focus groups; Lester Lloyd provided overview of DfL strategic process and found the survey to be extremely useful in organization; committee should find a way to get the pulse from all community members and have a professional organization help with this process
- FG: Primary goal of committee is to continue to build spaces for open dialogue among all members of our community; attended meaningful conversation at DfL this week
- MD: Definitely need survey; embrace spaces were folks feel comfortable sharing and speaking about belonging is critical
- CS: Establish and facilitating conversations were all members of our community feel valued and heard is paramount
- DK: Point of the summit was to create a listening space where productive dialogue takes place; there are a variety of groups advancing a sense of belonging, this committee should focus on survey and also perhaps PR various events / create one calendar where all community members can find events that are meaningful to them
- o MJ: Interfaith council is an organization that has a uniting force; this organization is looking for ways to help those who need it, and continue to establish a sense of community and belonging
- KW: At the next town meeting, are we able to give a brief overview of what the community has accomplished so far and let folks know what our next steps will be?
- FG: Yes, definitely
- MG: In agreement to amplify different areas in the town that are doing great work as well as centralizing this information to create a shared awareness; we as members of this committee should also try to engage with other groups we have not yet heard from and engage in dialogue with them
- SS: Create spaces for intellectual discussion on various topics relating to DEI, belonging, etc.
- JH: Appreciate comments shared; grassroots conversations and continue on the path we are on, in a way that is joyful, engaging, and open to all viewpoints; consolidated events calendar is excellent idea; survey is vehicle to something else, focus groups perhaps better option

- OK: Revisit proclamation then telegraph all information of what has happened since proclamation; what information are we looking for on a survey? How do we engage various populations within the community to gain more insight on experiences?
- KW: MMA resources; lots of great information there including survey MMA did, how did it go?
 Is this a model we could use potentially?
- JH: Complete the survey as town rep; MMA used a consultant and the questions being asked drilled down to community representation, lots operational questions; it was overwhelming but helpful in thinking about how to make systemic changes moving forward with funding from MMA
 - 50K available 1/25/2025; grant provided for expenses associated with project management
- FG: To summary, we move forward with survey, calendar, brochure for town meeting; survey to be completed in collaboration with consultant / external organization, use this group for focus groups as well
 - Reach out to consultants who we previously connected with as well as consultant who MMA used to aid with survey and focus groups
 - DfL and CS will work on calendar, brochure / update for Town Meeting
 - Moving forward monthly meetings with this game plane
 - Brochure: amplify community initiatives as it relates to proclamation; safe & welcoming; share at town meeting
 - Selectboard meeting post-Town Meeting, our DEI steering committee can share progress to date
