

#### CONVENED IN OPEN SESSION

I. <u>CALL TO ORDER</u> This meeting was called to order at approximately 7:00 pm.

# Discussion regarding Collective Bargaining Settlement – Library

Mr. McGee moved that the Selectboard accept the Library settlement agreement, as presented.

Seconded by Ms. MacNab Roll Call Vote: Mr. Guitart-aye; Mr. Flynn-aye and Ms. MacNab-aye. Mr. McGee-abstained (he was not present for the executive session.)

# Discussion pertaining to Selectboard intention to Lay Out McLean's Way as a Public Way.

Mr. Read stated: Last month I spoke with Town Counsel about the upcoming Special Town Meeting in October and the idea of including an article for the acceptance of McLean's Way on the warrant. I indicated we needed to be 100% accurate on the timing of the process and further to make sure that the correct process be outlined, a proposed article be drafted and to establish a calendar timeline for this purpose. Counsel responded with everything we needed. I have discussed this process with both Dr. Reinhalter and his attorney, Robb D'Ambruoso, Esq., and we are clear on the process and the need for an easement from the Association (which Robb is pursuing.) With that, as advised by Town Counsel, tonight the Selectboard needs to vote its intention to lay out McLean's Way as a public way (the motion for a vote is below) and then refer the layout to the Planning Board for its nonbinding

recommendation (the draft referral for which is attached.) At a later meeting the next step will be that the Selectboard adopt an Order of Layout, laying out McLean's Way as a public way at a public meeting after the Planning Board has submitted its report and the Town has given Notice of the public meeting.

Mr. McGee moved that the Selectboard vote its intention to lay out McLean's Way as a public way, all as shown on a plan entitled "Subdivision As-Built Plan McLean's Way Duxbury, Massachusetts", dated April 13, 2020, prepared by Grady Consulting, L.L.C., which plan is on file with the Town Clerk, and to forward this vote and the plan to the Planning Board for its comments and recommendations pursuant to G.L. c.41, §§81G and 81I.

Discussion regarding Alden House Historic Site's funding request from the Heritage Fund Ms. Mobed gave brief description of the Alden House and the use of the funds from this request. Mr. Keiser, 100 Park Street, gave an additional history of the Fund.

Mr. McGee moved that the approve the requested expenditure in the amount of \$5,000 to the Alden Kindred of America to put towards the construction of their Center for Living, as presented.
