Ms. Tanya Trevisan spoke on the behalf of Ms. Lynch-Benttinen regarding the Cranberry Bogs. Mr. Guitart stated that this has been put on the schedule for discussion. Mr. Read stated that he had emailed Ms. Lynch-Benttinen and was awaiting her return from vacation to schedule a meeting with the Selectboard. This will be sometime in November. Ms. Trevisan wanted to bring to the Selectboards attention the pictures in the email she had sent. Ms. Trevisan also wanted to speak for the Duxbury Safe Water Inc. They had met with the BOH regarding the Depot Street Well. The question was whether the Depot Street Well would be put back on line. Mr. Guitart did not have a response to her question. Ms. Trevisan also inquired about identifying residents in town with potable wells, and would like to have that information. Ms. MacNab stated that it is in the working for this specific map. Ms. Trevisan also inquired about the ground water flow map which should have been completed by Sept.1<sup>st</sup>. Ms. Mayo, BOH Agent, responded to the mapping question. Ms. Mayo stated that the map was just completed and Ms. Mayo does have the map showing the well locations for the whole Town and areas of concern. The ground water flow map was attained by Mr. Mackin, Water Dept., from Weston and Sampson. Ms. Trevisan was pleased with the responses she had received.

Whereas the boundaries of the layout of McLean's Way are shown on a plan entitled "Street Acceptance Plan for McLean's Way Duxbury, Massachusetts", dated January 7, 2020, prepared by Grady Consulting, L.L.C, which plan was referred to the Planning Board and which plan is hereby adopted as a part of this order, and all land lying within the layout of McLean's Way is hereby laid out as a public way.

The aforementioned plan is hereby forwarded to the Town Clerk for filing and the foregoing layout is hereby reported to the Town for acceptance.
