V TOWN MANAGER'S REPORT

Mr. Read shared the following: these are things you will see coming up in future agendas in the summer and fall of this year. The first two will be next week, a review and discussion of the Draft Master Plan and Water Quality Study, done by Environmental Partners Group, LLC. Also, the review and discussion of the PFAS testing results at the former McNeil Dump which will be handled by Weston & Sampson, Inc. Following that there will be a discussion with the Duxbury Nuclear Advisory Committee providing an update regarding Holtec and any of the next steps associated with that. Future improvements to the Budget process and financial planning. Envision Duxbury Implementation plan, that would be an update from the Planning Board. Duxbury Beach Reservation and Beach Operations, that would be an update from the Recreation Director and Beach Operation Director and Cris Luttazzi as well. Historic Districts, specifically the Simmons Farm or Harrington Property, an update with the LHDC-Tag Carpenter, they are getting ready to put out the RFP for that process. Follow up with the Duxbury Bay Commission regarding the state of the Bay and the Aquaculture Moratorium. Most likely that will take place toward the end of the summer beginning of fall. Climate Resiliency, an update on current and future projects, coupled with a follow up on Conservation Commission recommendations that you had heard from them about. More towards the fall - a discussion with the Highway Safety Committee regarding a possible Town wide 25mph speed limit, which then may lead to DPD staffing and future COPS Grant opportunity. Mr. Guitart thought it was a good list and it helps them to stay on track. Mr. McGee inquired about having a fall town meeting and the possibility of McLean's Way being on the upcoming attractions. Ms. MacNab was anxious to find out about Holtec and where they are at and would like to see that scheduled sooner rather than later. Also, the PFAS water quality study is a big document and recommended that the Water Advisory Committee look at it. Mr. Read said he would look into getting it to them. Ms. MacNab would like to have a BOH meeting to update the town with what they are grappling with. Ms. MacNab shared Duxbury FACTS and perhaps getting them on the agenda to discuss funding for the Town that gets funneled through a committee. Mr. Read said he would look into it.

Mr. Carpenter wanted to speak about the Historic District and inform the Selectboard that the process to sell the house is coming to a head, and the RFP will be sent out. Mr. Read stated that is why it is on the list - to review with the Selectboard. Mr. Carpenter stated they are in the final drafting stages of the RFP and will provide them with a finished document by June 15th. Ms. Ladd Fiorini stated the Selectboard would get them on the agenda after that. Mr. Guitart inquired if all were satisfied with the list of future items for discussion, and all were satisfied. Mr. Read added that the first and second crossovers were closed due to the Plovers.
