Zoning Recodification

The zoning bylaw document was split into sections for the Planning Board members to review. Mr. Ryan will distribute the document to other departments for internal review.

Mr. Ryan discussed the need for a table of dimensions, and the need to check cross references.

Mr. Casagrande asked the members to be complete their cursory review by the next meeting.

A redlined and a clean version of the document will be maintained going forward.

Mr. Casagrande said after the internal review, they can have the outside contingent review the document. This process is essentially a recodification and any policy changes will happen after this process.

The use table that lists all the uses in the current zoning bylaws will be included in this recodification, and then the use table can be updated as a separate article. Mr. Uitti suggested the Board get a use table that is agreeable with the stakeholders, and go forward with that.

Comprehensive Plan Implementation

Mr. Ryan discussed the work Tag Carpenter has done, further organizing the Comprehensive Plan Implementation Table so it is easier to break apart the tasks each group is responsible for, for example adding an "Owner" column for each task, listing what group will be taking on the task.
