unfounded complaints and just basically wanted to
complain about us and the town not standing up to us
even though we have a contract.

- Q. At that point, what was your relationship with Gordon Cushing and MacDonald?
- A. It was -- well, MacDonald I don't think became the -- he was the building inspector, but I don't know if he became -- I don't know if he was town manager in early '04. I don't know if Rocco left in '04 or '05, somewhere in there.

Gordon relationship was fine. I remember saying to Gordon, what's the deal with this, Gordon, why are they -- why are they so upset. We're not telling them they can't play 18 holes. We're telling them that we're going to open it up the way it should be and if other people want a tee time, they're going to get it and we'll fit them in somehow, but it's not good enough for them.

Gordon -- Gordon was fine. I mean, he'd say, first of all, you know, take it from the source, but he did tell me -- he told me that both Betsy Sullivan and Andre Martignetti or whatever his name is listened to those guys, so...

Q. When did he tell you that?

A. He told me that in '04. He told me that in early '04 after the newspaper because there was a -there was a hearing. I believe it was a special selectmen's meeting or maybe just a regular one where they invited -- I didn't go because I was away -- but Kelly, my daughter, went with Joe Eckstrom and they sat up on the stage with Gordon.

I'm not sure if Troy was there. I want to say no, but, maybe, he was, but Gordon was up there and maybe Bill Dixon, the chairman at the time, or maybe it was someone else.

But I remember saying to the Gordon, I had a phone conversation with him, I said, "What is the problem," and I said, "This is crazy."

And he told me -- he goes the one thing I will tell you, though, is that Sullivan and Martignetti or Martecchini, whatever his name, they listen to those guys, so that -- that was what I got from him.

- Q. Now, this meeting that you're talking about, you said people were sitting up on the podium. Who was on the podium?
- A. I think they were on the stage, but -- or, probably, I guess at the town hall there where, you

know, it's like a little stage.

O. The mural room?

- A. Yeah. Kelly Johnson, at the time Johnson, Joe Eckstrom, Gordon. I'm not sure whether Troy was there or anybody else. I think the chair -- whoever was chairman of the North Hill Advisory Committee I think was there too.
 - Q. And the selectman?
 - A. I'm not even sure about that.
- Q. Were some of them known to you as select people then?
- A. I don't believe -- yes, they were. They were the select -- there were two of three selectmen at the time.
- Q. And it was at this time that you say Gordon Cushing told you that?
- A. It was shortly -- it was probably before the meeting because I wanted to know what the big deal was why Joe and Kelly had to go to this hearing, what's going on, I mean, what -- what -- this is a simple thing.

We made a decision, you know. I mean, what's the big deal. We're entitled to do it. So, you know, that's -- it just didn't make a lot of sense

to me at the time.

- Q. And that's when Gordon Cushing told you that those two selectmen listen to these people?
 - A. Correct.
- Q. So what happens after this meeting? Oh, by the way, what was Joe Eckstrom's job then?
- A. Joe is my director of operations who oversees the grounds at each of our facilities and plus he interacted with Gordon much more than I did, so, you know, he was there. Plus, like I said, I was away so they were both representing me.
- Q. Who else -- was anybody else present when Gordon told you this?
 - A. No, because it was a phone conversation.
- Q. Did you tell anyone else at around that time that he had said that?
 - A. Yes.
 - Q. Who'd you tell?
- A. I'm sure I told -- I'm certain I told Kelly and Joe.
 - Q. So what happens after the meeting?
- A. I think at the meeting it was left that town council would make a ruling or decision, and Troy ended up saying that I had the right to do that so

they -- they --Q. So Bob

- Q. So Bob Troy -- was it in writing?
- A. I think so, yes. I think there is something in writing somewhere.
 - Q. And then what happens?
 - A. So they -- they were not happy with Troy.
 - Q. How do you know?
- A. Well, I know they didn't like -- I know they didn't like his decision.
 - Q. How do you know?
- A. They expressed it over and over again for the next four years.
 - O. Where?
- A. North Hill to my staff, a number of people made statements to my staff that you'll never -
 Johnson will never be back here. He'll never get another contract in town.
- Q. I need names. Any names of people who said it or of the people who heard it?
- A. Bill Curley. I'll give you the names of the people that I can.
 - Q. Father or son?
 - A. Bill the basketball player.
 - Q. Who did he say it to?

He said that to David Marcinkoski. 1 Α. 2 Spell that? Q. 3 Α. M-A-R-C-I-N-K-O-S-K-I. 4 Ο. Who is he? 5 Α. He at the time -- he's a lifelong friend of 6 mine who was working and helping us out at North Hill 7 as a starter, ranger. 8 Q. Where is he now? 9 Α. He's in Florida. 10 Ο. Where? 11 Α. Saint Augustine. 12 Ο. That's on the way here. 13 He'll come up believe me. Α. No, no. 14 sort of a -- the way the story went was a pretty 15 interesting thing where Mr. Curley just thinks that 16 the world revolves around him, but... 17 Q. He was pretty good. 18 Α. Okay. But, you know, why not -- there was 19 no reason for him to do the things he do. 20 What'd he did? Q. 21 He used to sneak on the golf course without Α. 22 paying green fees. He got caught three times I swear. 23 MR. KREIGER: He's six one. It's 24 not easy to sneak anywhere.

THE DEPONENT: I know, but the thing is he'd get mad when he got caught and was asked to pay and that's when he -- he told this particular gentleman that let me be the first to tell you Johnson will not be back with a new contract.

Q. When was that?

A. I would say it was probably the summer of '08. He was one of the later -- he had cousins.

There was another guy named Bill Curley also who was a member at North Hill Country Club that was his cousin, but he knew the crowd.

Bill Curley himself, the basketball player, didn't -- he wasn't a member at North Hill, but his son took lessons from our golf pro there. So he would have occasion to come by, and that's when he basically would get caught late in the day.

His son -- he actually had his son join. He was a junior member and he decided to go and play with his little boy, but he decided that didn't need to pay.

- Q. He was wrong.
- A. Well, I would think so, but...
- Q. So this is in '08?
- A. That was in '08.

- Q. That Curley told David Marcinkoski?
- A. Marcinkoski, yeah.
- Q. Had you heard that from any source before that?
- A. Yeah, numerous times. We had -- I guess in '06 see -- I think Amy worked there in '06 -- Amy Reuter became manager after Kelly -- R-E-U-T-E-R. I'm going to say she managed the last couple years, probably, '06, '07, something like that.
 - Q. Where's she now?
 - A. She is in Washington, D.C.
 - Q. What's she doing?
- A. Kelly would know. Kelly keeps in contact with her.
 - Q. Okay.
- A. She heard -- she heard it -- I'm trying to remember -- she heard it plenty. One name in particular I can remember is Mike Sales and pretty much heard it on a -- on a daily basis from different people that sort of was -- Amy, a very competent young woman, graduated from the University of New Hampshire, worked under Kelly for a while then became the manager.

And they burnt her out after three years.

She wanted out. She couldn't -- she didn't want to 1 deal with it listening to people with this stuff, 2 3 so... And she told you that she had heard from 4 Q. 5 various people that you weren't going to get the 6 contract? 7 Α. Correct. Did she give you any names? 8 Mike Sales, one I can remember were Mike 9 Α. 10 Sales, but there were others. I just can't -- I can't 11 remember them. 12 Q. Anybody else? Any other names that you can 13 associate with you hearing that you're not going to 14 get the contract? 15 Α. No, not that I can -- not that I recall 16 right now. 17 Did you hear it personally from Q. Okay. 18 anyone? 19 I don't think I heard it personally. Α. No. was not there that much so I don't think I would have 20 21 heard it personally. I think -- no, I'd say, no. Was there anybody else in your staff that 22 may have heard it besides Kelly and David? 23

Kelly, David, Amy, and probably Joe's

daughter, Brittany, who at the time was 18 years old.

I do recall Joe saying something that she heard.

Here's a high school girl behind the cash register, and people coming and going, yeah, by the way you're not going to be here next year or two years or whatever it was, and totally, you know -- that's -- that's uncalled for.

- O. Where is she now?
- A. She is a senior I think at BU.
- Q. Not as much fun as Rio. So you had this one conversation with Gordon where you recall that he told you that Betsy Sullivan and Andre Martecchini listened to these people?
 - A. Correct.

- Q. Any other conversations with Gordon or anyone else affiliated with the town about your concern that you weren't going to get the contract prior to the RFP coming out?
- A. I think there was a number of things that came up. I know I e-mailed him a lot pretty much we -- I knew what they were going to try to pull.
 - Q. How'd you know?
- A. From all this stuff, I knew they were going to try to pull something and I believe I had e-mails

to Cushing that said, look -- I, actually, even remember sending Doolin who was the chairman at the time the Web site to the inspector general's office saying, you need to go by this specifications.

I told Cushing that also by e-mail and I said -- and I -- I'm fairly certain I said to him, I hope you're not going to try -- and, maybe, not in these exact words -- but I hope you're not going to pull something because if you do, we'll be in a lawsuit.

I wanted them to understand that if they tried to cheat me, that I was going to come after them.

- Q. And did you get any response to that from Gordon or --
 - A. He'll pass it on to Richard MacDonald.
- Q. There's an e-mail written that -- an e-mail that I've seen -- forget that.

But did you ever tell Gordon Cushing that if he opened this process up to people who weren't running golf courses, you would sue him or words to that affect?

A. Something like that. I'm sure I said that -- like I said, I think I knew -- we knew what

they were going to try to pull. We knew that they -despite doing an outstanding job there for the years
we were there, that wasn't the goal.

The goal was to get us out of there at all costs. There's not a doubt in my mind. It didn't matter the job we did.

- Q. What was that belief based on other than what you've told me? You said these people said -- people were saying this. What else was that belief based on?
- A. The letter not only to the newspaper but then the letter that Michael Doolin sent to the selectmen. He sent basically the same complaint letter to the selectmen in early '04.

And the next thing you know this guy was appointed as chairman of the North Hill Advisory Committee, which totally -- I said, what the heck is going on here, you know.

So I didn't think that would be the -- it'd be one thing if the selectmen called me in and wanted my side or whatever they wanted to do to get two sides of a coin and make a decision, it never happened.

I mean, and I -- I think -- I'm certain that if -- I don't know if the town manager at that time

Longo was gone or not, but I could not see -- excuse 1 me -- I don't think he was there because I don't think 2 3 it would have happened if he was there. I don't think the guy would have allowed 4 5 this to happen. I think that he was too much of a straight guy to let this stuff go on. 6 7 So I know that Doolin and some others, 0. right, wrote this letter to --8 9 Α. Right. 10 Ο. -- the selectmen? 11 Α. Right. 12 Q. Did anything happen as a result of that or 13 after that? 14 After what, you mean as a result of the letter, yes. 15 16 0. Yeah. Marlborough was already -- Mike 17 Α. Yes. Marlborough was already on the committee at the time, 18 but then Doolin -- they appointed Doolin to the 19

It just so happens that all three of them work for the same people, Freeman Company in Braintree, which if I recall correctly, at their

depositions they were all somewhat shy or hesitant about saying where they worked.

And I don't -- I think only one of them said they worked for the Freeman Company. I think one said, well, I work in hospitality. They didn't want -- it's almost like they didn't want the connection to come out at their own depos was my own personal feeling.

- Q. Was that the first time you found out about that?
 - A. Yes. I never had a clue.
- Q. So did you ever attend the meetings at North Hill Advisory Committee?
 - A. Some, very few, Joe would usually go.
- Q. Was there problems at these meetings running up to the RFP issuance?

A. I don't think they were problems. Joe would say the -- the part that became totally, again, evident that they were doing something was, Joe would go to the meeting, meeting after meeting -- this is from '07 on -- and they would say, okay, Joe, you can leave now, and they would go in executive session right in front of Joe and say, we need to go over the RFP for the upcoming proposal.

And that became pretty alarming considering 1 2 the fact that Troy told everybody that no one in town had anything -- we -- we knew from the beginning the 3 first time we went to court and lied in court that he 4 5 was lying. We knew there was no consultant. We knew who was doing the RFP, it's, like, the most arrogant 6 7 stupid thing I've ever seen in my life. Q. The most, really? Come on. 8 It's, like -- I still remember with you --9 Α. I'd rather go off the record. I'd like to tell him --10 11 remind him of that day remember when --MR. FOLLANSBEE: Go ahead. Off the 12

- Q. (BY MR. KESTEN) But at the time -- I know -- I'm trying to keep you focused.
 - A. Sure.
- Q. I'm trying to keep you focused on what you knew then versus what you know now.
 - A. Okay.
 - Q. But back then --

A. Yeah.

Q. -- you haven't at least told me so far about any problems that Joe reported with them other than they said that he couldn't be there when they worked on the RFP which was understandable; right? That wasn't a problem, was it?

A. Yeah, no, and I don't think anybody -I mean, I do recall even in court Troy telling the
court that Johnson does an outstanding job. We get
great reviews from him.

So there was -- I don't think there was ever a question of our work. I never heard anything about that anyway.

- Q. You become aware before the RFP came out that they were -- that the town was looking to manage, for example, the tee time issue?
- A. No. They didn't -- they didn't consult with me on anything. That was just their own thing. I do remember that sometime in probably early '08 I gave Cushing a list of things that would be helpful to the town to maximize their revenue on the next RFP.
 - Q. Like what? Did you give it in an e-mail?
- A. I think -- no, I think in writing. I remember -- I probably have a list somewhere too still

about it and I believe it was in '08 because I know Joe and I met with him.

- Q. Met with who?
- A. Gordon.

- Q. To -- for what purpose?
- A. Just to discuss some of the stuff. I wanted to go over -- again, I think it was, you know, trying to -- I don't think they could have -- trying to work with them.
 - Q. And what types of things would you remember?
- A. Well, one of them would certainly be not to have fivesomes allowed on the golf course.

They had -- they had done RFPs there for at least 23 years prior to this '08 one and nowhere did it ever say that members could book 18-hole tee times, so they changed that for a purpose, and --

- Q. Let's go back.
- A. Okay.
- Q. Let's stay focused on what you knew then.
- 20 A. Okay.
 - Q. Before it came out.
 - A. Before it came out, okay.
 - Q. You say you met -- you and Joe met -- you and Joe?

- A. Yeah.
- Q. Met with Gordon?
- A. Yeah.
- Q. And made some suggestion to maximize revenue?
- A. Right. I believe some of it was capital improvement that they need to invest some money back into the golf course.

The last few years they were getting \$110,000 and they weren't investing -- they were putting peanuts back into it. They had a budget, like, of \$2,000 and it's like owning a house, if you're not going to upkeep your house, you know, you're going to be in trouble down the road somewhere.

So I know -- I had been telling them you should do a master plan of projects, keep up with them, and things like that which in my mind would improve the facility and then in turn would attract more people.

- Q. Anything else unusual that you recall happening before the RFP came out in October? It came out in October; right?
 - A. It came out I think in September. I know it

was due October, like, 24th so it probably came out in 1 2 September. No, I don't think I can remember anything 3 else unusual. How did you get the RFP? 4 Probably myself or Joe or Jason or Kelly 5 Α. picked it up at the town hall. 6 And you read it? 7 Q. Correct. 8 Α. 9 Q. And what did you notice? What leapt out at 10 you? Comparable business enterprise. 11 Α. 12 So what'd you do? Q. 13 Α. We put a -- well, we attended the prebid. When was that? 14 Ο. 15 It would have been sometime after the Α. 16 proposal -- the RFP came out and before the bid was due, so I'm going to guess, maybe, first week in 17 October. 18 19 Ο. Where was it held? At North Hill. 20 Α. 21 Q. And who was there for the town? 22 Α. Gordon. Just Gordon? 23 Ο.

Yeah.

I'm pretty sure it was just Gordon.

And who was there asking questions? 1 Q. 2 Α. Questions had to be in writing I'm pretty sure, but there were some questions anyway. I don't 3 4 think we asked any at the thing. We put ours in 5 writing. So you had submitted them before the prebid? 6 0. 7 No, after the prebid. Α. RFP went out I think September 26th? 8 Ο. September 26th. 9 Α. Is when it went out. 10 Q. Okay. And then the prebid was probably 11 Α. October 8th, somewhere in there or whatever. 12 So you went to the prebid conference and you 13 submitted the written questions? 14 We probably took notes at that and then 15 Α. we submitted them later. 16 17 Ο. So what happened at the prebid? There were some groups there that I think 18 Α. I looked around the room to see who was 19 were asking. there, seeing the golf business is rather small of who 20 21 the players are, and I noticed that we were the only legitimate golf company there. 22 Who else was there? 23 Q.

Steve Daley who bid, I believe -- I think

Gunnarson was there, Bob Gunnarson not the brothers. 1 Bob was, like, one of the other brothers of Rusty and 2 Dick who ran North Hill, and, maybe, a couple of the 3 other bidders or one of them who I didn't even --4 Emmett Sheehan was there. 5 Do you know him? 6 Ο. 7 I knew Emmett -- yeah, I knew Emmett because Α. Emmett was on the North Hill Advisory Committee, and 8 9 that's probably about it. Was Lanzetta there? 10 Ο. 11 Α. I don't think he was. I don't remember 12 seeing him there. He could have been but I'm not 13 sure. At this prebid, did you know who had bid? 14 15 I'm sorry. It's the prebid. 16 Α. Prebid, yeah, yeah. And what happened at this meeting? What did 17 Ο. 18 Gordon say? Well, people get to look around so they can 19 Α. look around the whole building, look at, you know, the 20 pro shop, kitchen, all this, go around the golf course 21 in a cart. We supply the carts for people to go 22 around. 23

And he might have taken questions, but I'm

fairly certain that he said they had to be in writing 1 so make your questions. You had till such and such a 2 date to put in writing your questions and then they'll 3 answer your questions. 4 How long was this prebid conference? 5 Q. Forty-five minutes. Α. 6 And then you submitted your written 0. questions? 8 Correct. 9 Α. And what happened? 10 Q. My recollection is I don't think very many 11 Α. 12 of our questions were answered. I think either none of them or very few were which was rather frustrating. 13 14 Ο. How did you get the answers? 15 Α. Never got them. So how did you get -- I mean, you got 16 Ο. answers, you got documents? 17 Oh, a document was sent to us maybe 18 e-mailed. 19 And this was before the bid -- before the 20 Q. bid? 21 22 Α. Correct.

And did you do anything to try to get

further answers?

- A. Yes.
- Q. What'd you do?
- A. I called Gordon up.
- Q. Tell me what you remember.
- A. I asked him what comparable business enterprise means, that was one of my big ones.
 - Q. And what'd he say?
 - A. He said something like it speaks for itself.
- Q. That's what Gordon told you or was that what's on the written answers?
- A. I think it was both. I don't think Gordon really -- he seemed to be very uncomfortable. I asked him about why they would allow fivesomes to play golf.

That was also a stickler with the North Hill Men's Advisory Committee. In the first contract that I got, Rocco Longo specifically made it clear to me no fivesomes play golf on that golf course so we would enforce that. Those guys hated it, absolutely hated it.

But now all of a sudden it was in this contract, so I asked him why that also. Then I asked him why the 18-hole tee times. I said, "Do you realize that by doing that you're lowing the income --

generating income which in effect affects the town so what you're really trying to do is have the town subsidize this group of golfers."

So he -- Gordon was uncomfortable and I don't believe he ever -- I know during that period of time he loved to say to me or he probably looked at me as a pain in the you know what, I'll pass it along to Richard, that was his standard answer to me.

- Q. So then you bid?
- A. Correct.

- Q. How did you decide what amount to bid?
- A. How do I decide to bid?
- O. What amount to bid?
- A. By my expertise of the golf business particularly in this case operating North Hill for as long as we had looking at everything and that's pretty much my expertise so -- so that's the way I judge my bid.
- Q. How much of a profit were you expecting to -- had you made before that year?
- A. I'm going to say we made a minimum profit, probably, for a few years at least three years and maybe more before that of probably about 150,000 a year.

Q. How did you calculate that?

A. Well, from the income generated by expenses spent. And on this particular RFP I did know that the first year of the new RFP the green fee rates were going up three dollars per nine holes.

So based on even -- I think the rounds were in the 20s, but based on 20,000 rounds of golf income would increase 60,000.

Then on membership fees they were going up a pretty good percentage too as my recollection. I think I had it calculated that the money would increase a minimum of probably 90 to a hundred thousand between both because in the years of running it under the old contract -- under the injunction we were stuck with the old contract, nothing went up.

So automatically -- and as a matter of fact

I know the day we left there because we were still

moving things out this group that got in there the day

we left they were charging three dollars more per nine

holes, so it automatically jumped up.

- Q. So you made the bid?
- A. Right.
- Q. And when did you first find out who else had bid?

A. It was a while because I know I asked Gordon, and he wouldn't tell me. And I -- I'm sure I checked with my attorney on what the law says once bids go in who bid, but it was sometime after that.

Cushing did release to us I'm pretty sure the bidders so I found that out sometime between October 24th and that letter in December that said they were throwing the bids out.

- Q. What did you make of the other bidders?
- A. Not qualified every one of them.
- Q. Now, you knew Daley?
- A. Correct.

- Q. How about the Gunnarsons, why weren't they qualified?
- A. He was -- Bob was bidding it as himself, and I believe they had -- I don't believe he had the experience as a company. I don't think he did the financials -- I think from -- really for the rest of them every one of them I don't believe met the financial criteria alone not to mention the experience of running a golf course.

And I -- he was a golf pro by trait. I know Bob was, but he wasn't one of the brothers that was running North Hill pre Johnson Golf so he wasn't

None of them were qualified except for us. 1 How about Sheehan? 2 Ο. The quy's a tree landscaper. He had no 3 Α. qualifications whatsoever to run a golf course. 4 What about Charlie? 5 Q. Charlie had qualifications in a different 6 Α. company, C.P.&L that was in bankruptcy at the time, 7 8 so, obviously, his little game was to -- I can't bid this because I'm in bankruptcy, so I need to fall back 9 10 on my former company CALM Golf that had \$169 in 11 assets. 12 Q. Well, you didn't know that at the time; right? 13 14 Α. Oh, yeah, I did. 15 Q. How'd you know? 16 Α. Well, because we had bid against him. 17 was the one in Abington. We -- I was very familiar with his little game. 18 19 CALM Golf? 0. 20 Α. Yeah. 21 Now, he had run -- what courses had he run? Q.

he actually was the owner of Rockland for a long, long

Only Rockland, he actually met Rockland --

time, but he lost it.

That would have been another -- in my view would have been another concern to me of, wait a minute, this guy went under at this place and lost a golf course and let me be the first to have him run my place.

- Q. So do you recall that you told or at least notified Gordon Cushing about --
 - A. Him being in bankruptcy, correct.

- Q. Now, did you give information about anybody else?
- A. No, 'cause I knew the rest of them had no -- at least Charlie had -- he didn't meet the evaluation criteria, but at least he had golf experience.

The rest of them there was no need to. It was clear as a bell that they had never operated golf courses so they don't qualify by the town's own criteria.

- Q. Do you recall that it took some additional time or an unusual amount of time to get a decision the first time?
- A. Yes. And I also kept asking why so long when I'm the only qualified bidder.
 - Q. And what did you hear?
 - A. I'll pass it on the Richard. Richard's the

decision maker.

- Q. How'd you find out that they had cancelled the whole bid process?
 - A. When I got the letter.
 - Q. How'd you get it?
- A. I think mail. It might have been certified or it might not have been. I don't really recall, but I did get it by mail.
 - Q. What'd you think?
 - A. I was not surprised.
 - Q. Why?
- A. Because I knew they weren't going to give us the contract.
- Q. Did you talk up -- until the time you got the letter, did you have any other conversations with Gordon Cushing or anyone on behalf of the town about the process other than what you've told us, that you would ask him and he would tell you he'll pass it on?
- A. I might have and Joe might have. I know Joe did, maybe, not me, but if I did, I'd probably say the same thing Joe said to him.
 - Q. And what did Joe tell you he was hearing?
- A. Well, Joe I think made it clear to Gordon that you don't -- this isn't the first time this has

- Q. I want to make sure that you have now told me everything you remember of any information you got from any source that you were not likely or you were not going to be granted this contract. You've told us about some things other people have heard. Gordon Cushing telling you that Betsy and Andre listened to these people. Is there anything else that you heard from any other source, any other information you

received from any other source? 1 2 No, not -- I don't think so, you know, also Α. 3 including, of course, the letter to the newspaper, the letter to the selectmen. And I -- at that meeting 4 with the selectmen I do believe Andre Martecchini was 5 there at that meeting where Joe and Kelly were there. 6 Is this the meeting back in '04 about the --Ο. 8 Α. I think it was January '04. -- about the double tee times? 9 Ο. 10 And I -- my recollection too is that Α. Yeah. 11 they were pretty much trashing me at that meeting, but 12 Andre was there. 13 Had you had any dealings with Bob Troy up 14 until this point? 15 Α. No. 16 MR. FOLLANSBEE: Which point are we 17 talking about? In December of '08. MR. KESTEN: 18 MR. FOLLANSBEE: All right. 19 20 MR. KESTEN: Before the suit was filed. 21 Oh, only to do with the pilot tax program 22 Α. there because on the old contract for that old 23

clubhouse the payment used to be, like, \$3,000.

And then when we built the new clubhouse, they billed me for 10,000 -- that was probably one of the reasons also why I did what I did -- but they were billing me for 10,000. I'm certain I paid the first few years of that contract and then I said, no, this is wrong.

I was paying 3,000. I build you a clubhouse and then you charge me ten, so Troy -- I did meet with Troy. I think Steve was there. Steve and I and Troy and I guess it was when MacDonald first took over so it must have been '05 or '06, something like that, but they did then agree to lower the payments to -- I think it was 4,000.

- Q. Had you had any dealings with Richard MacDonald prior to December of '08 other than the meeting about the house?
- A. Only when we built the clubhouse, he was the building inspector so he would come around and inspect.
- Q. But as town manager there were no interactions that you recall?
 - A. None at all.

Q. Do you have any knowledge of any hostility or ill will from -- by Betsy Sullivan against you

other than Gordon Cushing telling you that she 1 listened to the people of the North Hill Men's Club? 2 Only when she was deposed and described me 3 Α. as whatever she described me as where -- seeing I have 4 never met this woman personally in my life. 5 appeared at two meetings in all the years at the board 6 of selectmen. 7 Ο. I'm not there yet. 9 Α. Okay. I'm focusing on sort of chronologically. 10 Ο. Α. Yeah. 11 So as of December of '08 --12 Q. 13 Α. Yeah. -- you were not aware of anything --14 Q. 15 Α. about getting 18 holes of golf, that was, like, their key thing.

So I had arranged to have a golf course architect come to a meeting, North Hill Advisory

Committee meeting, and along with the director of the national golf foundation to give them the logistics of doing it, the land all that, Brian had walked the land.

They invited Martecchini and he totally just chopped their legs off. After he left that meeting, those guys were so disappointed because -- and I think he expressed it as he didn't recall going to any meeting, but he did -- but he vetoed the whole thing. He told the group now is not the time to build 18 holes and that squashed that.

And I think after that time there were a series of people that got off that committee rather than stay on because it disappointed them so much.

- Q. So you filed suit?
- A. Correct.

- Q. You went to the hearings?
- A. Correct.
- Q. Did you have any interactions -- well, the first hearing was December of '08?

A. Well, we -- we knew -- we did know that -under 30B that you don't need to have a composite
score, a total composite score, you have to do the
categories correctly, but you didn't need a composite.
As far as --

- Q. How do you know that?
- A. It's in the rules of Chapter 30B which over the years I've gotten to know most of it pretty well. And then did we know that he -- the IG -- he said the IG met -- which he never spoke to the IG at that time, maybe, because I, myself, called the IG's office right after that letter.

And then I talked to a guy named Craven, and then Steve talked to him after I did. The guy's -- wouldn't -- he wouldn't move on anything. He just -- I thought it was very strange the whole thing.

- Q. You called the IG's office right after you got the letter canceling the bids?
 - A. Right.
 - Q. And you spoke to John Craven?
 - A. Yes.

Q. What do you remember about that conversation?

A. I told him what had happened. And I said,
"I believe that something is wrong here. We were the
only qualified bidder. They took whatever number of
weeks to make this decision."

I told him that -- because it was also -- I remember the only thing that was fishy was there's price and nonprice proposals. So when you open the nonprice proposal, that's how you know if someone's qualified. If they're not qualified, you don't even open up their bid.

So as -- and as I believe Cushing and MacDonald and/or maybe Troy testified they knew right away at the bid opening that these bids weren't done right, well, why did they open up price proposals if they weren't done right? Somebody was done right and that was us so that just raised a red flag with me and I -- I --

- Q. Right now I'm focusing on your conversation with Craven.
- A. Yeah. And that's what -- well, I told

 Craven that. I told him why would they open that up

 if -- if you're not -- why do you go any further, you

know, if you do that.

- Q. What did he say?
- A. It was -- I didn't get a lot of stuff out of him. I'll check into it. I'll let you know. I'll get back to you, something like that. And I never heard back and then I got ahold of Steve and had Steve -- Steve got ahold of him.

- A. Oh, yeah, actually, Jason did and pointed it out to me and said it.

A. Cushing -- it was set up by Steve and Troy in that we would deal through Cushing totally. And it sort of -- it was tough in the beginning because they wouldn't let us renew the liquor license which licenses are renewed in November.

And we had told them, look, if we're not the successful bidder, we'll just transfer the license.

It's not a big deal. We've done this before in other towns. Let us get the license, so, no, they wouldn't.

So then we start without a license, a liquor license, and it was -- by the time we got the injunction was -- what? mid-February. We weren't -- we didn't even -- when we got back in operating it was probably still snowing.

We didn't get operating till May -- I mean till March, so we were short money. We had to reapply for a whole new liquor license, which took, like, ten weeks, so that was a pain.

We operated -- it was agreed upon -- I think the judge stipulated that it would operate under the

a

old contract, so we paid them the average payment of the ten years and we paid them -- seeing we didn't start till March we had -- in my opinion -- I remember Troy saying some ridiculous thing of we owe them money -- but we paid them a hundred thousand from March to -- till through December so that became for those two years the schedule March through December a hundred thousand.

And I think the year we left Troy was trying to say we owed him two months' rent which was ridiculous.

- Q. Any major problems operating in '09?
- A. No, because the group that didn't like us very few of them were playing golf there. They had picked up and left shortly after the whole court thing.

Doolin, the chairman, who was a member for a while didn't become a member. I think he testified in his deposition that he wasn't going back to that golf course till I was out and that was the feeling.

So as far as normal people we had -- there's a lot of nice people there with families, husbands and wives that in my opinion loved us, but they weren't the crybabies. They didn't make the noise so they

weren't the squeaky wheel.

- Q. So in '09 was your volume similar to what it had been in '08 or '07?
- A. No. It went I think -- I can't remember specifically, but my memory is that it went down in revenue because of the uncertainty of the golf course.

It was well publicized. The paper at the time was trashing us over and over again. The town every year for the 14 previous years we had run the course they used to put the advertisement in the newspaper for us that memberships would go on sale November 1st, and that's why I say the junior memberships would be sold out in two days. People used to stand outside to get their kids in.

And when we were awarded by injunction in February, I asked Cushing if he would do that. He said he'd pass it by Richard, never happened.

They were -- and then we found out later they were still telling people not to join. They were telling them don't get your dues in. We're still not through with this. We're going to be contesting so it created --

Q. And how'd you find that out?

People that came in. People that were --Α. 1 that used to be members that would come in and go, you know, I don't know what to do, you know. We had a 3 I don't know what to do. number of those. 4 telling me I shouldn't join. - A. I did -- I think it was '09 one of the guys on the North Hill Advisory Committee, James Ford, I believe he sent a letter to Cushing in early April complaining about the condition of the golf course, which Cushing came out, went around the golf course, spoke with me, went around the golf course with Joe.

We wrote a written response, and then

Cushing basically told this guy to knock it off. It

was totally unwarranted and it was his way of filing a

complaint I would say.

- Q. Any other problems in '09 that you recall?
- A. No.
- Q. When's the time you went to Troy's office? Was that in 2010?
 - A. I think that was in July of '09.
 - Q. Tell me about that.
 - A. Wow, that was a good one.
 - Q. Unforgettable.

He asked Troy -- Steve went with me, and I 1 Α. 2 think it was in July of '09 -- he wanted to know if I was interested in rebidding the golf course. 3 4 Ο. How do you know? Did he say that to you or 5 is that something you heard from --6 Α. Oh, he said it to me. I was in his office. 7 Ο. So you were invited to a meeting? Α. I think our plan was --20 Who went? 21 0. Just Steve and I, Gordon Cushing, and Bob 22 Α. 23 Troy.

So I said, "Okay. Tell me specifically how I'm difficult to get along with."

And he said something to the effect, I heard you're -- and I said, "Oh, okay. Who did you hear it from?"

And he couldn't give me any answer.

And I said, "I've got a better idea. Gordon Cushing's right there. He works with us so Gordon am I difficult to get along with?"

And Gordon said, "No." So then we had another little brief exchange because I had had about enough of this guy anyway, but -- so --

- Q. So you became difficult to get along with?
- A. No, he did. I'm never -- I'm never difficult to get along with, no.
 - Q. All right.
- A. It's just that some people can't handle the truth. That's the problem that I have.

So something happened again. I'm trying to remember exactly, but he -- he, again, inferred that I

was difficult to get along with.

And then I said to Cushing again, "Gordon, you want to answer that again?"

And then Troy goes, don't answer that. And that was basically the end of the meeting. We got up and walked out. He was going to throw me out too. He might have thrown me out.

MR. FOLLANSBEE: Oh, there's no doubt about it.

THE DEPONENT: Yeah, I think he did ask me to leave, so, okay, nice seeing you. So, therefore, I went down -- it actually you know now that I think of it, Lenny, it sort of reminded me of that meeting we had in March when we went down there thinking that we might be able to work things out and he threw us out of there too so that was the way.

- Q. Well, that was not a --
- A. I get a kick -- that shocked me when he asked me if I wanted to rebid. I mean, I'm going, wow, I must look stupid I guess.
- Q. So you shut the golf course down at some point in the fall?
- A. Depending on the weather. Some winters we've been open year-round, you know, through the

winter, the whole deal. We try to be -- accommodate everybody.

A lot of those guys, the die-hard guys, the old guys always a great group of weekday guys, you know. They'd be the weekday members, the old guys. Most of them very nice guys just want to play their golf, don't want to get involved in the politics.

So if we could be open to them in the winter, we were open, you know. They had no -- they'd drink. They'd come in have their coffee, the whole deal, you know, so they were good.

- Q. So you then move into the oh, ten season?
- A. Yeah. Can I back up for just one thing 'cause talking about old guys just reminded me of something. There was a guy that did tell me to my face that I wouldn't be going there back under contract.
 - O. Who is that?
 - A. Bob Doyle.
 - Q. And he is Mike Doolin's father-in-law?
 - A. Correct.
 - Q. When did he tell you that?
- A. He told me that shortly after the hearing in '04, the tee time policy. He -- he used to -- when

he'd come around, it was always to complain. He was well known complaining about everything that went on there.

The bar was too -- we built the clubhouse -- I think there's a newspaper article when we built the clubhouse. And he's sitting in the new clubhouse as it's under construction and he complained to the newspaper that the bar was too big, so he was just one of these chronic complaining style guys.

- Q. Does he have any kind of position in the town?
 - A. No.

- Q. And he's a regular player?
- A. He was -- I don't think he was ever a member, but he used to play. He would complain -- I remember it was sort of funny when, you know -- in the original contract, it would say we'd have coupon books for seniors where they would get a discount, you know, so they'd buy a book of ten plays and get a discount of a buck or two bucks or whatever it was.

So we had a year where I think Jason and Kelly implemented it we changed to technology with cards so you'd have a -- he'd get a card now. We had the cards, but he went and complained to the town that

we don't have coupon books anymore.

so we had to explain to the town that we have -- we've upgraded our system here. You don't have to worry about losing your coupon. You get the card and, plus, you're on file with the card so that's what we did, but he complained about that so that was sort of funny.

- Q. And how did it come about that he told you this?
 - A. He told me that we wouldn't be back here?
 - Q. Yeah.

- A. He just didn't like me. The funny thing is --
 - Q. The guy just came up to you and --
- A. He was -- if I was around, he'd always find a way to find me and say stuff so he liked -- I think he liked to -- whatever, give me the business or --
 - O. Trash talk?
- A. Yeah, and half the time when he got older, like, in the last -- he -- when he got really old, he didn't even know who I was. That last incident with him he didn't even know who I was.

When he found out who I was, he walked back in to confront me. If was funny. It was good. He

didn't even have a clue who I was. He went in and asked -- he asked Bill Kiniry and Joe, who is that anyway? He goes, that's Doug Johnson.

So he told me -- walks back into the bar and starts giving me the business.

Q. What'd he say?

A. Just started bitching at me, I'll be glad when you're gone, this and that.

And I just said, "Look, you need to be quiet, okay." I said, "You need to knock it off and get away from me." That's all, so...

- Q. And when was this? This was back in '04 you think?
- A. No. This was -- that last time was, like, two years ago in 2010.
 - Q. That's when the police were called?
 - A. Yeah, yeah.
 - Q. But I'm talking about --
- A. Way back -- well, yeah, he -- he -- that guy was like that from Day 1 1995. He supposedly -- and I -- he used to work for the Gunnarsons, so whatever we did at North Hill he hated.

He absolutely was totally one hundred percent against Johnson Golf Management of anything

That was his big thing. that went on in that town. 1 He was just a pain in the you know what. 2 complained about every -- he'd complain about a candy 3 I mean, he'd complain about anything he could 4 find. 5 But it was back in '04 that he told you --6 Ο. at that point he knew who you were? 7 Oh, yeah, his mind was still pretty good 8 Α. then. 9 How did it come about? He came walking by 10 Q. 11 you and --I think it had something to -- I think that 12 Α. it had something to do with the -- the -- he didn't 13 like when the building was built that the bar was big 14 and he had a comment about the bar. 15

So he didn't 17 like that. 18 19 I don't know why people think that you would Ο. not be as nice as you are. 20 Well, this guy -- this guy -- that's too 21 Α. good for him, so -- so he didn't know who I was, so --22 23 He just thought it was a random guy. Q.

24

Α.

No, what he did then -- then I had to go --

I went into the bar to get a soda and whatever so I'm behind the bar.

And he left and went in the pro shop, then he comes out storming at me, right, so I'm pouring a drink. So he goes -- he swore at me, called me a couple names.

And I said, "Just leave. Okay. You need to leave." And I believe I did make a comment. I said to him, "If you were 40 years younger, I'd kick the crap out of you right now," but I just said get away from me.

He wouldn't leave. He goes back and tells
Bill Kiniry and Joe, call the police, this and that.
And I think Bill -- I don't know because I wasn't out
there, I'm just going by what they said later -- he
said, what are we going to call the police for? Why?
What went on? What happened, and it was nothing that
happened.

And so as a matter of fact I just went about my business went out the back door and I left. So then police came. I had a detective call me a couple days later, talked to him, and, you know, I told him just what I told you.

And he said, "Well, you know you got to be

These old guys, " you know -- the guy's 80 --1 careful. 2 whatever he was. And so I said, "Yeah, I know. Ι 3 understand." 4 The guy could have a heart attack. 5 I said, "Really." I said, "What about me?" 6 I said, "I've had a heart attack, so what? He can do 7 that to me, but I'm not going to say something. 8 9 That's not what I do." So the cop was fine about it. He did his 10 report, did his job, and I never heard another word 11 after that so I don't know. 12 So you're into 2010? 13 Q. Α. Yeah. 14 Things are proceeding along in court. 15 0. did you first find out that they were going to try to 16 17 have hearings? I think they sent me a letter with these --18 it started out as ten violations of the contract. 19 Did you hear anything about this before you 20 got the letter? 21 Α. No. 22 So this was sort of out of the blue? 23 Ο. 24 Α. Yeah, yes.

So you got the notice of violation? 1 Ο. 2 Α. Right. You tried to stop the hearings in court? 3 Q. Yes. 4 Α. It didn't happen. The hearings proceeded? 5 Q. I responded to their complaints 6 Α. 7 first too in writing. And was it October 4th when you 8 Ο. Right. presented your stuff to the -- is that the first 9 10 hearing you presented your stuff to the board of 11 selectmen, your settlement package? I went to a selectmen's meeting in 12 Α. Oh, no. I think it was, like, March or April of 2010, walked 13 into -- yeah, because the selectmen were Sullivan, 14 15 Witten, and Donato. So I brought in -- this was after Lanzetta 16 17 had been deposed, CALM Golf, and MacDonald, and after reading the depos counsel conferred with me about, 18 look, we should try to make every effort to try to 19 20 settle, so I agree. So I brought them in these, like, packets. 21 I think there were four. One for the town manager 22 They must have been this thick (indicating). It 23

had the depos -- complete depos of MacDonald, of

Lanzetta, all kinds of other letters. I think we had tried to settle with them even off the bat, like, a month after all this went out when the judge -
(Whereupon Mr. Laramee left the proceedings).

A. -- Judge Smith had ruled that he found it incredible that they could rank CALM higher than -- the one great thing -- that was one of the two times that I've come in contact with Betsy Sullivan.

I remember when the new business thing came up, I raised my hand, and she was smiling. And then when I said who I was, her smile turned into this, like, real bad frown.

So I said, "Look, I'm just here -- I have some information. I know you know we're in litigation. I have some information that I'd like to give you to go over and perhaps we can talk about it and settle this or whatever."

She goes, well, we can't do it right now.

I said, "I understand that." I said, "I've got these things. I'm happy to give them to you."

And then on my way -- that's all I said. It took a minute and out the door I was.

So I gave them all those packets and that

was the first time I had presented -- but, like I said, I can remember even at -- I think at MacDonald's deposition I think Steve and Troy -- Steve tried to talk to Troy about settling this saying, look, you know, you've got to read what the judge says and whatever and all this other stuff.

And Troy was -- I guess it went in one ear and out the other, whatever.

- Q. There was a hearing regarding the bond in the fall of 2010?
 - A. Correct.

- Q. At which you made some remarks to Gordon Cushing --
 - A. I think I said --
- Q. -- about what Troy had said to the judge about the amount?
 - A. Oh, that was in court.
 - Q. Yes.
- A. I've got to get my dates right. I want to say -- okay. That had to be November of 2010 in court. Wow, I think the bond that was supposed to be in place was, like, 150,000 by contract.

But we couldn't get bonded anyway in the litigation years because no bonding company would

litigate me.

And I did tell the town that. I gave it to them in writing. I told them. I said, "Look, I'll be happy to put up as collateral my equipment here. I've got a half a million dollars' worth of equipment.

I've got all this stuff, whatever you want to do is fine with me."

(Whereupon Mr. Laramee joined the proceedings).

A. So that became unacceptable. Troy came up with this thing to the judge, look, he's got no security.

And the judge did say, all right, that was an oversight on my part. I am going to order them to get security. How much security do they need?

Troy goes, we need at least 300,000.

And then so Steve argues, Your Honor, they don't take in that much money in memberships. There is no money that they have.

I believe Troy even lied or misrepresented he was trying to tell the judge we had already taken money in which was totally ridiculous for the next year. We didn't do that.

So Steven tells the judge that they take in

about a hundred thousand in memberships a year.

That's it.

So Troy goes, well, I have the town manager and the rec director right here. Will you give me a minute, Your Honor, to confer with them. So he goes back talks to Troy and MacDonald sitting right there watching us.

MR. FOLLANSBEE: Cushing.

A. Cushing and MacDonald, and he goes and he tells the judge -- he goes, Judge, they take in 350,000 in membership money, and we need more than that. We need a half a million dollars in security.

I'm sitting there going, you got to be kidding me. So the judge, you know, again, he's not thinking that attorney's a liar, but that was it. He goes, okay. I order you to get a half million in security so the scramble was on.

But Steve then filed a motion --

- Q. Tell me something on the way out though --
- A. Yeah, I asked Cushing --
- Q. What do you remember about that interaction?
- A. I said to Cushing -- Troy, Cushing, and MacDonald were right there, and I said to Cushing, "That's pretty good, Gordon, you told them that we

take in 350,000 in memberships."

And he said he never said that which I don't know if he did or didn't. Only him and Troy know that and MacDonald I guess.

So we fought and then they reduced it to 200,000, and I ended up getting security. It took me a couple of months, but we did get it so we did have the security in place when they finally threw us out anyway, you know, but...

- Q. Tell me about the liquor cart. It was one of the charges against you.
- A. There was never a liquor cart or a beer cart out in that golf course in '09 or '10. I'm going to say that before that, maybe, in '07 or '08 it's possible that there was for, like, certain things, tournaments.

But the liquor license, itself, said on it -- and I actually -- the liquor license said the entire nine hole -- something to this effect the entire nine-hole golf course and clubhouse, so that's what our liquor license said.

I didn't feel I was doing anything wrong.

And then upon further investigation I think the fact is that that was allowable when the Gunnarsons did

it. We never started doing it probably -- we probably did it for two years, '06, '07, something like that.

But the reason it came about was because

Massachusetts passed a law I think in '08 that they

were going to allow beer carts on golf courses so you

had to apply for a different license than your liquor

license.

So what I did -- I opened it up because I said, look, I'd like to apply for this license to put a beer cart out there, and, you know, it's policed. I have ServSafe people, TIP certified people, all this stuff.

So that opened up their little scheme I would call it to, oh, he's been -- he's been serving liquor out there.

And I know in Cushing's affidavit Cushing said that we were doing it and then under -- in his own depo he said he never saw that, so -- and the -- so truth is we never did it in '09 and '10 when we were litigating.

There's no way I'm going to -- well, I wouldn't do it once I -- I applied for that license and opened that up in '09. So once I knew there's a whole different license, I didn't -- regardless of

what the license said, I didn't care. I just said I'm 1 not going to put myself in that position. 2 Before you got the notice of charges --3 Ο. Α. Yeah. 4 -- had you gotten any indication from anyone 5 Ο. in town that there were problems? 6 7 Α. No. The first thing you got was that notice? 8 Q. 9 Α. In 15 years, they never complained 10 about anything about us. Now, when they went out -- when they sent 11 Q. out the invitation to bid? 12 13 Α. TFB? 14 Ο. Yeah. 15 Α. Yeah. Did you review that? 16 Q. 17 Α. Yes. And why didn't you bid? 18 Q. 19 Α. There's a number of reasons, but the ones that stick out in my head was, basically, it was a 20 ten-day contract that they could throw you out in ten 21 22 days. Other things were that you can't litigate 23

You can't --

against the town if you have a problem.

any decision or discrepancy was to be decided by the town manager of Duxbury, number of things like that.

So the way -- I said, how can I bid this contract. It's impossible. I have friends also in the golf business that are competitors of mine. We're friends, but we're competitors.

They sent that IFB packet out to roughly 13 different parties of -- which of the 13 probably eight or nine were legitimate companies. No one bid it, zero.

And one friend of mine, as I said a competitor, called me and said, "What the heck is this?" And he said, "What is going on there?"

And I just said, "You're reading it too,

Murph, so you want to bid it be my guest." So I

wasn't going to bid it. I mean, I -- there's no way

you could bid it.

I think the thing is a civil rights violation myself anyway. If you have a problem, they're telling you can't litigate. I mean, that doesn't make a lot of sense to me.

- Q. Who's Murph?
- A. Steve Murphy.
- Q. Oh, that one.

1 Do you know him? Α. 2 That's like John Smith. Ο. 3 His company's Golf Facilities Management. Α. 4 They -- they -- let me see, they operate Gannon 5 Municipal up in Lynn, Beverly Golf and Tennis. I 6 think they got one other one too. Where is it? 7 Maybe, North Reading, North Reading or something like that. 8 9 So he called you? Ο. 10 Yeah, we talked, yeah. Α. 11 Q. And said he got this package? 12 Α. He got e-mailed the stuff. 13 Q. Who else got it? 14 Α. I think Sterling got it, but I don't recall 15 talking to Sterling about it, Billy Casper got it. 16 Ο. What's the name of his company? 17 Α. Sterling Golf, Billy Casper Golf Management. 18 There were a number of them. 19 How did you know who got it? Q. The e-mail -- I believe the e-mail went to 20 Α. 21 Jason, and they actually e-mailed out the -- saying that there'd be an IFB going out to bid. 22 23 The other thing I remember about the IFB is 24 that Troy in court in November was telling the judge
