The Coastal Resiliency Task Force (CRTF) met on November 20, 2023, at 4:00 PM in the McCluskey Room at the Duxbury Senior Center.

Convene

The meeting was called to Order by Mr. Amory at 4:00 PM.

Minutes

The review of the meeting minutes from November 6, 2023 was postponed to a later date.

Discussion

New Members:

All CRTF present acknowledged that additional task force members are needed. Nancy Rufo will provide the names of interested citizens interviewed during the original selection process. Mr. Cerne did not decide whether to join as a member, citing other responsibilities.

Resiliency Planner:

Ms. White offered to collate earlier versions of a job description for a new position to assist the Town Planner, as a coastal resiliency assistant planner. Although the Town Manager did not support such a position, at the November 6 meeting, all parties agreed CRTF would proceed with defining the role.

MVP Grant:

Ms. Rufo summarized the email she received, stating that CRTF did NOT receive an Accelerated Resiliency Grant from MAPC, filed by the Woods Hole Group for education and outreach. All parties agreed that although the grant was denied, Woods Hole could still serve to develop an outreach program for CRTF, using monies available from the vacant Town Planner position. Ms. Rufo also suggested using the Annual Town Report as a way to update citizens on CRTF activities.
