1. CALL TO ORDER: Zoom preamble read by Alicia. The meeting was called to order at 4:05 PM.

The Easement document would have to be amended on the floor at Town Meeting.

 - 3.3 *Review and Discuss Draft of Project Development*-Alicia discussed DBRA and Webster Island Association possibly sharing a website for residents. This would provide ongoing outreach to the beach community. Separate tabs for each association with main site for DSWC and other area information for all.
 - 3.4 *Status Letter Writing Campaign*-Arthur completed draft letter to Senators. Steve gave information to several residents. Overall, we will need more encouragement as Infrastructure Bill comes to forefront in Washington.
 - 3.5 *Review DSW Policy*-Don contacted Pete Buttkus regarding new policy distribution. A letter from the Town will be sent to individuals living along the wall.
