At a minimum, the project shall consist of the removal of all numerals, minute markers and clock hands from the clock dials with new numerals and minute markers to be fabricated and installed which shall match the original profiles in size, shape and color; restoration of the four (4) clock faces; installation of the clock hands onto the drive shafts and the clocks set.
