# **Open Forum**

No one from the Board or the public brought anything forward during the open forum.

#### **Committee Appointments**

Mr. Glennon would like to continue with his role on the Open Space Committee and is also interested in joining the MBTA Advisory Board. Mr. Wadsworth is interested in joining the Community Preservation Committee. Ms. Turcotte stated at the last meeting that she would like to continue on the Diversity, Equity and Inclusion Steering Committee for another term. Ms. Hadley will pass this information along to the Selectboard.

#### ZBA Case #2022-14: 59 Standish Street

Mr. Glennon noted that this is a case where the accessory apartment is already within the home. He noted that this is a good example of housing diversity. Mr. Casagrande said there is a need for legal accessory apartments in Town.

# Comprehensive Plan Implementation

Mr. Casagrande said the Board is scheduling a joint-meeting with the Selectboard to discuss Comprehensive Plan implementation. Mr. Glennon noted that this is a follow-up to the joint meeting in March, in which quarterly joint-meetings were suggested. Board members discussed potential dates for the meeting, and decided to schedule the joint meeting for Monday, July 25 at 7PM. Ms. Hadley will follow up with the Selectboard to confirm.

#### Planning Director Search Update

Mr. Glennon said the hiring committee held several rounds of interviews with candidates and made a recommendation of a finalist to the Town Manager. The applicant received and accepted the job offer, but they are working on the required paperwork, background check, and follow-up information. Mr. Casagrande said they are hoping the new Planning Director will be able to start sometime in July.

#### **Other Business**

Mr. Casagrande said they will continue working on the Zoning Bylaw rewrite once the new Planning Director starts working.
