

2019 Resident Sticker Application

Please read instructions carefully before completing

Stickers may be purchased online by visiting: www.town.duxbury.ma.us

1. **All vehicles:** Enclose a copy of the valid registration and valid same name driver's license for each vehicle receiving a sticker.
2. **Leased vehicles:** Enclose a copy of the lease agreement showing name & vehicle ID.
3. **Company vehicles:** Enclose written authorization on company letterhead stating that the vehicle is for personal use and submit copies of valid registration & valid driver's license.
4. **Applications must be postmarked no later than April 30, 2019**, to receive a discounted rate(s).
5. **Senior rates apply to individuals age 62 and older at time of purchase.**
6. **Mail application to** Resident Sticker Dept., Town of Duxbury, and 878 Tremont Street, Duxbury, MA 02332-4456
7. **A self-addressed stamped return envelope must be sent with payment.**
8. **Please make checks payable to Town of Duxbury.** Temporary and out-of-state checks will not be accepted.
9. **Stickers are valid from** April 1, 2019, through March 31, 2020.
10. **Beach Stickers are limited to 3 per household with a maximum of 2 over sand.** There are is no limit for Transfer Station Sticker
11. **Stickers are non-transferable and non-refundable.** If the vehicle is sold or destroyed in an accident, old sticker(s) must be returned for a replacement fee of \$10 each. **Full price will be charged if a sticker is not returned.**
12. **If renting your home**, please plan your beach sticker purchases accordingly (see line 10). Renters must provide a copy of a written and signed rental agreement, vehicle registration and driver's license.
