


# **Meeting Notice**

#### REMOTE MEETING PREAMBLE

#### I. CALL TO ORDER

- ZBA Case #2020-15, Hammel, 246 Gurnet Road (CONT'D): The Applicant propses to raze and rebuild a pre-existing, nonconforming dwelling. A Special Permit is required.
- ZBA Case #2020-16, The Village at Duxbury, 290 Kings Town Way: The Applicant proposes to modify their free standing sign that was granted originally with Special Permit 89-17. A Special Permit and Variance are required.
- ZBA Case #2020-17, The Duxbury House, 298 Kings Town Way: The Applicant proposes to erect a free standing sign. A Special Permit and Variance are required.
- ZBA Case #2020-20, Carlin, 8 Pine Point Road (CONT'D): The Applicant proposes to raze and rebuild a pre-existing, non-conforming dwelling. A Special Permit is required.
- ZBA Case #2020-23, Sheehan, 77 Gurnet Road: The Applicant proposes to construct a deck on a pre-existing, non-conforming dwelling. A Special Permit is required.
