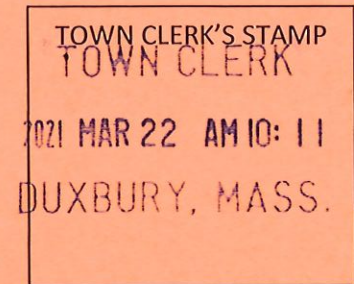

### **REMOTE MEETING PREAMBLE**

#### **I. CALL TO ORDER**

- **ZBA Case #2019-17, WB Builders Duxbury LLC, Fieldstone Farm, 1 & 25 Lincoln St.(CONT'D):** The Applicant proposes to construct thirty-two (32) single family detached condominium homes-eight (8) of which will be affordable to meet the definition of low and moderate income housing under G.L.c. 40B, Sections 20-23 and eight (8) homes will be age restricted as 55 and over.
- **ZBA Case #2020-16, The Village at Duxbury, 290 Kings Town Way (CONT'D):** The Applicant proposes to modify their free standing sign that was granted originally with special permit 89-17. A Special Permit and Variance are required.
- **ZBA Case # 2020-17, The Duxbury House, 298 Kings Town Way (CONT'D):** The Applicant proposes to erect a free standing sign. A Special Permit and Variance are required.
- **ZBA Case #2021-05, Andrew, 403 Washington Street-APPEAL:** The Appellant requests the Board of Appeals overturn the Zoning Enforcement Officer's decision to deny a building permit to construct a manufacturing distillery.
