S. 2157 Sen Su Moran – Joint TUE

The department of public utilities, in consultation with the department of energy resources, shall study the potential repurposing of decommissioned or inactive power plants within the commonwealth. The study shall examine all inactive or decommissioned power plants within the commonwealth, including any power plants in the process of becoming inactive or decommissioned. The study shall examine the potential uses for repurposing of said power plants including, but not

limited to:

- (a) transitioning to become a fusion energy power plant; and
- (b) transitioning to use for energy storage as a battery power plant.

The listings of matters are those reasonably anticipated by the chair which may be discussed at the meeting. Not all items listed may in fact be discussed and other items not listed may also be brought up for discussion to the extent permitted by law.

The department of public utilities shall submit the results of the study to the clerks of the senate and house of representatives by December 1, 2024.

DNAC Article 2024: Moratorium On The Construction Of New Nuclear Power Plants In Massachusetts
