310 CMR 7.75: Clean Energy Standard (CES) Update (Provided by email 01.18)

- On 12/15, we filed final amendments to ensure consistency between the CES and the
 Department of Energy Resources' implementation of the 2016 Energy Diversity Act.
 These amendments will be published in the Massachusetts register on 12/29/17. These
 changes followed a stakeholder and public comment process this past fall.
- This fall, MassDEP and EEA also conducted a review of options for expanding the CES. The review included publication of a stakeholder discussion document, several stakeholder meetings, and submission of numerous stakeholder comments. The regulatory amendments mentioned above resulted from this review, and additional amendments are possible in 2018. Prior to formally proposing any additional amendments, we will provide opportunities for stakeholders to comment on specific regulatory approaches.
