## **SAVE OUR BAY**

Pilgrim nuclear power plant is now being decommissioned. As part of the decommissioning process, Holtec, the company that owns Pilgrim nuclear power plant, plans to discharge as much as a million gallons of radioactive and chemical liquid waste into Cape Cod Bay.

At 7:00 pm on May 11, the Duxbury Nuclear Advisory Committee will hold an important presentation at the Senior Center on Pilgrim's plan to discharge that contaminated water into Cape Cod, Duxbury, Kingston, and Plymouth Bays, all of which are protected ocean sanctuaries..

We will explain and answer questions on important issues. How tides will bring the contaminated water into our bays and how long they will likely stay there. How the discharge will impact our local economics- shellfish, fin fish, marine based industries, tourism, and real estate.? How could the discharge impact our health? What are the politics and legal issues? And what can you do to protect our bays?
