#### Pending Bills Massachusetts Legislature 2019

1. O'Conner and Cyr – money for decommissioning – S1992 and S1948- \$25 million per year, starting in 2020 (Lamperts)

2. deMacedo (S1949) and Muratore (H2904) – level of residual radioactivity after license termination; assess costs incurred for radiation control; assess for site remediation.(Chin)
3. Cutler (H3492) and Cyr (S1943) – fully fund Commonwealth and municipality off-site radiological response emergency responses until all spent fuel is removed from spent fuel pool and placed in dry casks. (Landgren)
4. Balser (H1847) – monitoring stations throughout a 20-mile radius, store KI in towns within 50 miles, distribute KI to residents within 10 miles, nuclear disaster brochure to each household within 50 miles – all until fuel rods have been removed from reactor, placed in dry cask storage or moved off-site.
5. Meschino – (H1970) – assess each not less than \$500,000 for first fiscal year, and thereafter “in amounts that, in the aggregate, are equal to the costs incurred in the prior fiscal year by the department’s radiation control program in the performance of its duties under this section,” to defray costs of DPH radiation control program.(Gagnon)
