Pursuant to Massachusetts General Laws Chapter 40C and the General By-Laws of the Town of Duxbury, Massachusetts Chapter 12 Local Historic District Bylaw, notice is hereby given that the Duxbury Local Historic District Commission will hold a public hearing on Thursday, March 8, 2018 at 7:00 PM at the Duxbury Senior Center (Walker Room), 10 Mayflower Street, Duxbury, MA, 02332, for public input and comment regarding the creation of three new Local Historic Districts in Duxbury, Massachusetts: the Surplus Street Historic District, the Washington Street Historic District, and the King Caesar Historic District.

The SURPLUS STREET HISTORIC DISTRICT consists of three lots located at: 26 Surplus Street 119-087-000 COREY DAVID P Co-Owner BREAKFIELD XANDRA O; 47 Surplus Street 119-098-000 COREY DAVID P Co-Owner BREAKFIELD XANDRA O; and 218 Surplus Street 108-965-001 LAHEY ALLEN C Co-Owner LAHEY JOANNE I.

The WASHINGTON STREET HISTORIC DISTRICT consists of two lots located at: 259 & 265 Washington Street 120-177-001 HEMSLEY MAARTEN Co-Owner HEMSLEY MAVIS; and 338 Washington Street 119-083-000 RICE WILLIAM P.

The KING CAESAR HISTORIC DISTRICT consists of one lot located at 120 King Caesar Road 134-404-095 DUXBURY RURAL & HISTORIC SOCIETY INC.
