**REVISED PUBLIC HEARING NOTICE  
DUXBURY PLANNING BOARD &  
DUXBURY TREE WARDEN**

Notice is hereby given, pursuant to Chapter 40 Section 15C (Scenic Roads) and Chapter 87, Section 3 (Public Shade Trees) of the Massachusetts General Laws, that a consolidated public hearing will be held by the Duxbury Planning Board and Duxbury Tree Warden in the Large Classroom, second floor of the Duxbury Senior Center, 10 Mayflower Street, Duxbury, MA 02332 and via Zoom, on **Monday, May 20, 2024 at 6:05 PM**. Proposed work is related to the roadway entrance for the Definitive Subdivision recently approved at 333 Franklin Street, and involves the potential cutting of three trees and removal/relocation of approximately 60 feet of stone wall in the Right-of-Way of Franklin Street, a scenic road. The trees will be marked with a tree hearing notice and are described as follows:

Two ~12" Cedar Trees  
One 40" Twin Pine Tree

Any person interested or wishing to comment on the proposed plan should appear at the time and place noted above. A copy of the application, plans, and other supporting documents will be available on the Planning Board's webpage at <https://www.town.duxbury.ma.us/planning-board> or by contacting the Planning Department's office. Any individual with a disability may request accommodation in order to participate in the public hearing and may request the application and any accompanying materials in an accessible format. Such requests should be made at least three business days in advance by contacting the Planning Department.

Pursuant to Chapter 2 of the Acts of 2023, this meeting will be conducted in person and, as a courtesy, via remote means in accordance with applicable law. Please note that while an option for remote attendance and/or participation is being provided as a courtesy to the public and board members, the meeting/hearing will not be suspended or terminated if technological problems interrupt the virtual broadcast, unless required by law.
