

## PUBLIC HEARING NOTICE DUXBURY PLANNING BOARD

Pursuant to MGL Chapter 40A and Sections 406, 611, 615 and 906.2 of the Town of Duxbury Zoning Bylaws, the Duxbury Planning Board will hold public hearings in the Large Classroom, second floor, of the Duxbury Senior Center, 10 Mayflower Street Duxbury, MA 02332 and via zoom on **Monday**, **July 24, 2023 at 6:01 PM** to review requests for an Aquifer Protection Overlay District Special Permit and a Land Clearing and Grading Special Permit for a new Department of Public Works (DPW) Facility at 878 Tremont Street. The meeting will also include an Administrative Site Plan Review for the proposal. The proposal is to construct a new Department of Public Works (DPW) facility at 878 Tremont Street to replace the current DPW facility, and complete other related site improvements. The new facility will continue to serve as the DPW's operational hub, and all existing structures on the site, except the Harbormaster Building and Animal Shelter, will be demolished to make space for the proposed facility.

Any person interested or wishing to comment on the proposal should appear at the time and place noted above.
