

Topic: Marshfield - Duxbury Coastal Resiliency

Time: August 27, 2020 7:00 PM Eastern Time (US and Canada)

Location: Remote ZOOM meeting

The Towns of Marshfield and Duxbury were awarded a grant in the Fall of 2019 from Massachusetts Coastal Zone Management (CZM) for the design and permitting of beach and dune nourishment projects at vulnerable locations along the Towns' east facing shorelines. The proposed nourishment projects will improve shoreline resiliency by helping to maintain and improve the elevation and width of the existing beaches in order to strengthen the Towns' existing approach to management of the shoreline, which includes regular maintenance and repair of existing seawalls and revetments.

This project is a continuation of a previous CZM funded project in the Town of Marshfield that evaluated the feasibility of using sediment dredged from Green Harbor as a source for beach nourishment. The Town of Duxbury has been added as a partner to the project to facilitate a more comprehensive review. The current project is carrying forward the public engagement process that took place with the Green Harbor project.

An online public presentation is scheduled for August 27, 2020 from 7:00 to 9:00 PM to describe the findings of the project. A question and answer period for the public will follow the presentation.
