





Base map information shown on the FIRM uses 2013 and 2014 imagery provided by the U.S. Geological Survey and 2016 transportation data provided by the U.S. Census Bureau, with all other vector data unchanged from the

Coastal Barrier Resources System (CBRS) areas and 'otherwise protected areas' (OPAs) are no longer shown on this map panel, but still may be present in this community. Current information on these areas is provided by the U.S. Fish & Wildlife Service (FWS). NFIP flood insurance is not available within CBR areas for structures that are built or substantially improved on or after the dates indicated by FWS. Users should reference the most up-to-date information provided by FWS to determine NFIP insurance eligibility.
