CONSENT AGENDA

(Beginning with Article 11 – Several Articles to be Indefinitely Postponed)

Warrant Articles on a Consent Agenda are exceptions to the general process of Town Meeting. Before I ask for a motion under Article 11, it is this Moderator's impression that we may be able to expedite the consideration of Articles 11, 12, 17, 19-26, 29-31, 40 and 41. The intention is to Indefinitely Postpone these articles until a Fall Special Town Meeting, the date of which is still to be determined. Therefore, I will ask the meeting whether it would like to take all such articles together, without debate, as a "Consent Agenda".

I will read each of the Consent Agenda articles, and if I hear any objection, we will remove that particular article from the consent agenda and restore to its original place in the Warrant. The remaining articles will be discussed individually, but voted on pursuant to one motion without debate.

MOTION:

I move that the Town take Articles 11, 12, 17, 19-26, 29-31, 40 and 41 out of order and that they be passed by consent without debate in accordance with the Motions published in the Consent Agenda provided; however, that if any voter, prior to the taking of the vote, requests the right to discuss a specific article, then said article shall be removed from this motion and acted upon in the ordinary course of business. These Articles, as printed in the Warrant, may be approved with a single majority vote.
