Plymouth, ss Greetings:

To either of the Constables of the Town of Duxbury, in said County:

In the name of the Commonwealth of Massachusetts you are directed to NOTIFY and WARN the INHABITANTS OF THE TOWN OF DUXBURY, qualified to vote in elections and in Town affairs, to meet in the Duxbury Schools Performing Arts Center, 73 Alden Street, in said Duxbury on SATURDAY, the TENTH day of MARCH, 2007 next, at 9:10 A.M. for a SPECIAL TOWN MEETING, for the transaction of any business that may legally come before said meeting:

Article 1

To see if the Town will vote to authorize the Town Manager to transfer from available funds appropriations previously voted at the Annual Town Meeting of March 11, 2006 for the Fiscal Year beginning July 1, 2006 for various Town Departments or take any action in relation thereto.

Article 2

To see if the Town will vote to appropriate by transferring from available funds or from free cash, a sum of money to pay unpaid bills of previous years which may be legally unenforceable due to the insufficiency of an appropriation therefor, or take any action in relation thereto.

To see if the Town will vote to rescind any Town debt as authorized and unissued at previous Town Meetings, or take any action in relation thereto.

To see if the Town will vote to appropriate a sum of money for the purpose of funding repairs to seawalls in the Gurnet Road area in conjunction with the receipt of a Grant from the Commonwealth of Massachusetts and to meet this appropriation, to raise and appropriate, transfer from available funds or borrow a sum of money for the purpose of this article, and further to authorize the Board of Selectmen to petition the Great and General Court for authority to assess betterments for the sums expended pursuant to any appropriation under this Article in accordance with Chapter 80 of the Massachusetts General Laws, or any other enabling authority,

or take any action in relation thereto.
